Road Updates

Roger Ayers states since he is obligated to pave roads he is who will make the decision on which paving company is used. Stone Paving quoted \$61k repairs & \$285k for paving with 1½ inch top coat. Roger Ayers says he will give Stone Paving \$310k for repairs/paving, and we would be responsible for around 30k for the remainder of the repairs cost. Stone Paving's repair area is much less of an area than the other quotes we received. Stone Paving should be responsible for some of them due to us not having yet entered into a roadway agreement with them yet.

All agreed we will ask for 350k from A&A, so we can use the company of our choice since it is a more thorough repair/top coat.
